The seminar will be held at the Cooper Center in Kamloops, BC. This facility is air conditioned and will be comfortable in the summer heat. Address and directions will be provided after registration.

Working spots are limited and will be awarded on a first come, first served basis. There will be a waitlist in order of entries received.

Entries will be accepted by email, not over the phone.

Cancellation Policy:

Cancellations must be received no later than June 14, 2024 and are subject to a \$25 cancellation fee. After June 14, 2024, if you cancel your working or auditing spot, a refund (less \$25 cancellation fee) will be provided as long as we can fill the vacancy.

If your dog is ill or injured and unable to attend, a refund will be given if a note from a veterinarian is provided.

If you become ill or have COVID symptoms, you must stay home.
